# Fall Protection Plans

- We continue to have workers put themselves in danger because they are not given a plan for safe access to tie off when working at heights in fall arrest.
- Workers need a safe work platform that is wide enough and can support their weight with a safety factor. This excludes climbing on racks, the mid or top rail of MEWPs, or from using a 2x4 or similar means.
- Fall protection plans are needed whenever we are working in fall arrest.
- This includes when a worker is transitioning from an MEWP to a safe work platform, they need a fall protection plan. This plan needs to identify a suitable anchor point, how it will be installed, the lanyards they need to use, etc.
